A. Indian Economy News

1. Rapid Increase of India's Clean Energy Sector:

India is the world's 3rd largest renewable energy producer with 40% of energy capacity installed in the year 2022 coming from renewable sources. India's installed renewable energy capacity stands at 166.4 gigawatt (GW) (including large hydro) as of November 2022. The sector has grown exponentially over the last decade and it has attracted investors from all quarters of the global financial markets. On 14th January, India assumed the presidency of the 13th assembly of the International Renewable Energy Agency (IRENA), the first international organization to focus exclusively on renewable energy. In his opening remarks at the agency's 13th assembly in Abu Dhabi, Union Minister of New and Renewable Energy Mr. R. K. Singh mentioned that the problem of climate change cannot be solved by one country. Some countries transitioning will not help, it will require collective effort.

Government of India undertook various reforms to promote clean energy which includes the General Network Access (GNA) regulations, green energy corridor scheme, Production Linked Incentive (PLI) schemes, state electricity distribution companies (DISCOMs) privatisation bids, ancillary regulations and the green hydrogen/green ammonia policy over the last decade. This improved the business condition for clean energy and invited capital sources domestic and offshore. In line with global developments, several new technologies like Battery Energy Storage System (BESS), Offshore wind, Green Hydrogen and associated business models are taking shape in the India's clean energy market. These new technologies will attract investment in Indian clean energy market.



2. International Year of Millets 2023:

The International Year of Millet (IYM) 2023 proposal was sponsored by the Indian government on the Prime Minister, Mr Narender Modi's, initiative and approved by the UN General Assembly (UNGA). The Declaration played a significant role in elevating the Indian government to the forefront of the IYM celebrations. The Prime Minister, Mr Narendra Modi, also discussed how he envisions IYM 2023 being a "People's Movement" and how India will become a "Global Millet Hub."



'Millets' were among the first crops domesticated in India, with evidence of their consumption dating back to the Indus Valley civilization. Millets are currently grown in over 130 countries and are considered a traditional food for over half a billion people in Asia and Africa. Millets are primarily a kharif crop in India, necessitating less water and agricultural inputs than other similar staples. Millets are significant because of their enormous potential to generate livelihoods, increase farmer income, and ensure global food and nutritional security.

The Food and Agriculture Organization (FAO) of the United Nations hosted an opening ceremony for the International Year of Millets - 2023 on December 6, 2022, in Rome, Italy. Agricultural and Processed Food Products Export Development Authority (APEDA) and DA&FW will participate in the Trade Show in Belgium in January 2023, where a multi-stakeholder delegation comprised of representatives from DA&FW, APEDA, start-ups, exporters, and Farmer Producer Organizations (FPOs) showcased the diversity of Indian millets through RTE and RTC millet-based products marketed by Indian companies, B2B, B2G interactions, etc.



Furthermore, Indian embassies in over 140 countries will take part in the celebration of IYM in 2023 by hosting side events involving the Indian Diaspora such as exhibitions, seminars, talks, panel discussions, and so on. In January, Embassy of India in Dublin organized the participation of representation from Health-care, Yoga Center, Ayuredic Doctors and provided dishes made with millets for tasting. Millet dishes were also served as part of the Republic Day celebrations.

3. India starts the World's longest Cruise on Ganges River:

On January 13, 2023, the MV Ganga Vilas, the world's longest river cruise, was flagged off by the prime minister, Shri Narendra Modi. In 51 days, the MV Ganga Vilas will travel 3,200 kilometers from Varanasi in Uttar Pradesh to Dibrugarh in Assam across 27 different river systems in Bangladesh and India. With a capacity for 36 passengers and 18 suites on board, the MV Ganga Vilas offers three decks and all the luxuries. The maiden voyage has 32 tourists from Switzerland signing up for the entire length of the journey.

The MV Ganga Vilas cruise is curated to bring out the best of the country to be showcased to the world. The 51 days cruise is planned with visits to 50 tourist spots including World Heritage Sites, National Parks, River Ghats, and major cities like Patna in Bihar, Sahibganj in Jharkhand, Kolkata in West Bengal, Dhaka in Bangladesh and Guwahati in Assam.



The journey will give the tourists an opportunity to embark upon an experiential voyage and indulge in the art, culture, history, and spirituality of India and Bangladesh. In line with PM's endeavour to boost river cruise tourism, the huge untapped potential of river cruises will get unlocked with the launch of this service and it will herald a new age of river cruise tourism for India.

4. India's overall quality infrastructure system in the Top 10 globally with accreditation system ranked 5th


The Quality Council of India (QCI), India's national certifying body, was recently placed 5th worldwide in the Global Quality Infrastructure Index (GQII) 2021. The 184 economies in the world are ranked by the GQII according to the quality of their infrastructure (QI). The standards system (under BIS) is ranked 9th, while the metrology system (under NPL-CSIR) is ranked 21st in the world, keeping India's overall QI system status in the top 10.

This is a sign of a New India in the Amrit Kaal with a focus on quality. The youngest of India's three QI pillars is its accreditation system, and in just a year, India has moved up to 5th place globally. Under the direction of Prime Minister Mr. Narendra Modi and the Commerce & Industry Minister Mr. Piyush Goyal, QCI is dedicated to building the "Made in India" brand's reputation for reliability and quality across the world.

The GQII gauges the relative progress of each nation's quality of life. Based on each nation's placement in the sub-rankings for accreditation, standards, and metrology, a formula determines each nation's score. With a few exceptions, like as India (10th), Brazil (13th), Australia (14th), Turkey (16th), Mexico (18th), and South Africa, the top 25 QI systems are primarily situated in Europe, North America, and Asia-Pacific (20th).

5. India Surpasses Japan and becomes the third largest auto Market



India becomes the world's third-largest auto market for the first time and surpassed Japan in 2022 (As per the report of Nikkei Asia). According to the preliminary results by the Society of Indian Auto-mobile Manufacturers (SIAM), the sales of new vehicles recorded 4.25 million units in 2022, while the sales in Japan totalled 4.2 million units.

The sales volume for commercial vehicles is expected to increase further with the inclusion of the pending fourth-quarter sales figures. It has been reported that India's auto market has fluctuated in recent years, mainly due to the credit crunch and Covid-19. However, the easing of the automotive chip crunch in 2022, helped in a significant recovery.

Most sales of new autos in India comprised, vehicles powered by gasoline, including hybrid vehicles. Maruti Suzuki, Tata Motors, and other Indian automakers saw an increase in their sales last year.


7. Enrolment in higher education crosses the 40 million mark in India

According to the government's All India Survey on Higher Education (AISHE) 2020-2021, the enrolment in higher education institutions increased to 41.4 million during 2020-21, crossing the 40 million mark for the first time. It registered an increase of 7.5% from 2019-20 and 21% from 2014-15.

The female enrolment has increased to 20.1 million in 2020-21 from 18.8 million in 2019-20. Female enrolment also witnessed a 28% since 2014-15. The Ministry of Education has been conducting the All India Survey on Higher Education (AISHE) since 2011, covering all higher educational institutions located in Indian Territory and imparting higher education in the country. The survey collects detailed information on different parameters such as student enrolment, teachers' data, infrastructural information, financial information, etc.



There is also an increase of 28% in the enrolment of the scheduled cast (SC) students and 38% increase in the enrolment of female SC students in 2020-21, as against 2014-15. There has also been a substantial increase of 47% in the enrolment of scheduled tribe (ST) students and 63.4% increase in the enrolment of female ST students in 2020-21, as compared to 2014-15. Additionally, it has also been noted that the enrolment in 2020-21, as compared to 2014-15 has increased in the specialized universities relating to defence, Sanskrit, biotechnology, forensics, design, sports, etc.

Highlights of Economic Survey 2023

The Economic Survey prepared by the Department of Economic Affairs (DEA) under the guidance of Chief Economic Advisor V Anantha Nageswaran highlights are as below:

- India's GDP growth is expected to remain robust in FY23 at 7 percent (in real terms). This follows an 8.7%growth in the previous financial year.
- Economic Survey 2022-23 projects a baseline GDP growth of 11% in nominal term as and 6.5% in real terms in FY23.
- India is Third largest economy in PPP terms, fifth largest in terms of exchange rate.
- While India's retail inflation rate peaked at 7.8% in April2022, above the RBI's upper tolerance limit of 6%, the overshoot of inflation above the upper end of the target range in India was however one of the lowest in the world.
- Electronics exports rise nearly threefold, from US \$4.4 billion in FY19 to US \$11.6 Billion in FY22.
- The year FY22 saw improvement in Gross Enrolment Ratios (GER) in schools and improvement in gender parity. GER in the primary-enrolment in class I to V as a percentage of the population in age 6 to 10 years for girls as well as boys have improved in FY22.
- RBI initiated its monetary tightening cycle in April 2022 and has since raised the repo rate by 225 bps, leading to moderation of surplus liquidity conditions.
- More than 220 crore COVID vaccine doses administered as on 06 January, 2023.
- Free food grains to about 81.4 crore beneficiaries under the National Food Security Act for one year from January 1, 2023.
- Overall Gross Value Added (GVA) by the Industrial Sector (for the first half of FY 22-23) rose 3.7 per cent, which is higher than the average growth of 2.8 per cent achieved in the first half of the last decade.
- As of December 2022, Forex Reserves stood at \$ 563 billion covering 9.3 months of imports.

I. Indian Export and Import to World in December 2022

India's overall exports (Merchandise and Services combined) in December2022* are estimated to be USD 61.82Billion, exhibiting a negative growth of (-) 5.26per cent over the same period last year. Overall imports in December2022* are estimated to be USD73.80Billion, exhibiting a negative growth of (-) 1.95 per cent over the same period last year.


